The following pages consist of our General Price List, Casket Price List and Outer Burial Container Price List, in compliance with the Federal Trade Commission's "Funeral Rule" for your information and benefit. Included within these price lists, there are several disclosures that are required by either Federal or State law. At the time you receive this packet, your director will tell you about all of these disclosures and request that you sign and date forms that indicate that you received all of them, both verbally and in print.

"Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent." (Authority cited: Business and Professions Code (BPC) Sections 7685(b), 7685.6 and 7745 and California Code of Regulations (CCR) Section 1258.4)

NOTICE REGARDING CREMATED REMAINS: A person having the right to control disposition of cremated remains may remove the remains in a durable container from the place of cremation or interment, pursuant to Section 7054.6 of the Health and Safety Code.

If the cremated remains container cannot accommodate all cremated remains of the deceased, the crematory shall provide a larger cremated remains container at no additional cost, or place the excess in a second container that cannot easily come apart from the first, pursuant to Section 8345 of the Health and Safety Code.

Payment in full is required 24 working hours prior to the furnishing of any merchandise, ceremonies or disposition. Acceptable forms of payment are cash, cashier's check, Visa, MasterCard and Assignable/Incontestable life insurance policies. There will be a 5% processing fee on all life insurance policies added to the Statement of Funeral Goods and Services Selected. We do not accept estate claims. Personal checks that are returned by your bank unpaid will incur an additional fee of \$50.00 and you will be required to replace it with a cashier's check within 24 hours of our notification to you of the unpaid check.

All information given to the counselor at the time funeral arrangements are made must be correct vital information prior to filing with the State of California. It is the Contracting Party's responsibility to provide the counselor with the correct information. If the information given is incorrect after the filing process has taken place, the death certificate must be amended. This can take several weeks and you will be responsible for all additional charges to amend the death certificate.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL SERVICES:

Basic Services of Funeral Director, Staff and Overhead Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangements conference with family or responsible party; preparation and filing of necessary certificates and permits; shelter of remains for the first 3 days.	\$ 400.00
Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs and equipment and inventory expenses.	
This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations and immediate burials.)	
Embalming Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing.
